You will have the satisfaction of seeing technology evolve from concept to user fulfillment. This multi-faceted position requires experience with software development life cycles, strong people orchestration skills, and technical creativity. As the only IT project manager, you will have the opportunity to define project management frameworks that can effect positive changes in the University!

ESSENTIAL DUTIES AND RESPONSIBILITIES

- Project Management duties include:
 - Define, Plan, Orchestrate, Drive, Deliver small/large operational/strategic initiatives involving cross functional business units
 - Clearly understand and document business needs to define project goals, then using project management tools to maintain project schedules and manage changes/risks
- Business Analyst duties include:
 - Partner with business users to understand requirements, collaborating to optimize technology adoption, strategizing to improve efficiencies with new technology
- IT Application Support duties include:
 - Perform ongoing analysis to optimize functionality and business value of key enterprise applications
 - Create and maintain documentation on enterprise application standards and service levels
 - Collaborate within IT to troubleshoot, resolve complex application issues and apply preventative measures

- Experience researching/implementing/enhancing ERP systems like Oracle or Student Information Systems like Jenzabar
- Working knowledge of Windows operating systems, VMware virtual machines, MS SQL databases, application development, programming/scripting, wired & wireless networking protocols, firewalls, and integration of technology components

Skills/Abilities:

- Having leadership skills to communicate effectively, drive change, and manage multi-departmental projects
- Excellent people skills, with the ability to influence stakeholders and train them on new processes
- Strong technical skills to diagnose technology issues with a strong understanding on how applications, operating systems, networks co-exist and integrate
- Knowledge of regulatory laws, current security trends, and security practices as they relate to IT
- Understanding of human resource management principles, practices, and procedures
- Highly self-motivated, self-directed, and attentive to detail
- Ability to effectively prioritize tasks for self and staff in a complex environment
