

Medical Assistant / Limited X-Ray Technician

JOB SUMMARY

We are searching for a reliable Medical Assistant to perform various office and clinical duties to keep our healthcare practice running efficiently. Our Medical Assistant will work directly with healthcare practice staff to collect test samples, maintain patient records, explain common medical procedures to patients and assist in basic examinations. As a Limited X-Ray Technician, he/she will perform diagnostic radiographic services allowed under the license.

ESSENTIAL DUTIES AND RESPONSIBILITIES

PATIENT CARE - Essential Function 1 (75-85%)

- Observes universal precautions while performing/assisting office procedures.
- Prepares patients and facilities for exams or procedures.
- Collects or assists with specimen collection, labeling as appropriate.
- Completes injections, blood draws, EKG tests, skin tests, and other tests as directed.
- Administers medications under the supervision of the Physician, PA or NP.
- Accurately performs requested diagnostic tests in the clinical area. Ensures an effective and efficient flow of patients. Accurately takes and records vital signs, documenting appropriately. Acts as a liaison with the patient and physician.
- Assists provider with discharge instructions and patient education.
- Acts as Data Steward by following appropriate procedures regarding requests, access and disclosure of PHI in accordance with HIPPA regulations, and takes necessary precautions to prevent unauthorized access.
- Performs diagnostic radiographic services allowed under a Limited X-Ray technician license including chest, spine and extremities.
- Positions patients and adjusts settings to limit radiation exposure while producing highquality diagnostic images.
- Maintains radiology records database.
- Coordinates dosimeter collection and radiation exposure metrics.
- Maintains Limited X-Ray technician license and continuing education requirements for the California Department of Health Services.

FRONT OFFICE BACK UP - Essential Function 2 (15-25%)

- Answers incoming phone calls, maintains records, prepares reports and updates patient files.
- Reads messages, clarifies patient requests / information, and forwards to physician.
- Follows up with patient in accordance with physician direction.
- Appropriately schedules, reschedules, cancels or confirms patient appointments.
- Reviews and verifies medical coverage and determines patient eligibility.
- Makes financial or payment arrangements as necessary.
- Counsels patients regarding insurance and eligibility.
- Accepts and processes payments when necessary.

QUALIFICATION REQUIREMENTS

- Ability to communicate effectively with patients and staff from diverse backgrounds.

- Must possess the skill, knowledge and ability essential to the successful performance of assigned duties including understanding of medical terminology.

- Two years healthcare experience required, preferably in outpatient primary care
- High School degree or general education degree (GED)
- Current Medical Assistant certificate
- Current CA Limited X-Ray Technician license
- Minimum 6 months experience working with an Electronic Medical Record system.
