

<u>Assistant Professor, Principal Faculty</u> School of Physician Assistant Studies

JOB SUMMARY

The role of a principal faculty member is to coordinate and teach courses/modules involved with the academic curriculum, provide lectures for professional practice and clinical seminars, facilitate workshops and labs, advise and evaluate students, and represent the School to the medical community as well as the Marshall B. Ketchum University community. The School is dedicated to excellence in education, service to the community, and research/scholarship and faculty have opportunities to participate and grow in each of these. Working together with an outstanding leadership team, the faculty member will realize the University's goal of reimagining the future of health care with an emphasis on advanced practice skills, clinical medicine, and interprofessional education.

ESSENTIAL DUTIES AND RESPONSIBILITIES

- Coordinates, teaches and evaluates the effectiveness of assigned courses and modules during the didactic or clinical portion of the curriculum.
- Prepares lectures/presentations and student assessments for assigned modules.
- Participates in coordinating, training, and evaluation of students in physical exam workshops, labs, and clinical skills sessions.
- Responsible for maintaining and ordering supplies for assigned courses/modules.
- Serves as the Academic Advisor to students throughout the program.
- Assists with ongoing program assessment, data analysis, and programmatic improvement, to include curriculum development and review and assessment of student learning.

- Serves on the Admissions, Self-Assessment, and Student Progress committees of the School of Physician Assistant Studies and/or other committees as requested.
- Serves on University committees as appointed.
- Carries out scholarly and professional activities that contribute to the school/profession and personal professional development.
- Assists with the recruitment of new students, clinical sites, clinical projects/research, and preceptors.
- Participates as clinician at community health fairs, interprofessional clinics, and other outreach projects supervising PA students as requested.
- Support program in continually meeting accreditation standards.
- Other duties as assigned by the Director of Didactic Education or Program Director.
