This is a full-time, 12-month, faculty position at the ranks of Assistant, Associate, or Full Professor. Desired expertise includes, but is not limited to, ambulatory care, community pharmacy practice, transitions of care, family/internal medicine, and pharmacotherapy. The College seeks a forward-thinking faculty candidate with a commitment to excellence in teaching, practice, and research. The faculty member reports directly to the Department Chair of Pharmacy Practice. Successful candidates must demonstrate the ability to clearly articulate ideas, achieve shared goals, and possess strong interpersonal skills. Responsibilities may include, but are not limited to, establishing a clinical practice site, precepting IPPE and APPE students, and mentoring pharmacy students in research projects. Teaching responsibilities include course coordination and instruction utilizing active learning techniques and student engagement. The successful applicant will also support College research initiatives and participate in service activities of the Department, College, and University. Candidates should have a terminal degree (PharmD or equivalent) and PGY1 residency training. Preference will be given to candidates with PGY2 and/or fellowship training, board certification, other credentialing, and/or previous academic experience.
