

# **Pharmacy- Director of Experiential**

#### **JOB SUMMARY**

The Director reports to the Associate Dean of Clinical Affairs and Community Outreach. In collaboration with the Associate Dean of Clinical Affairs and Community Outreach, the Director is responsible for the planning, implementation, and assessment of all experiential education activities at the COP. The Director works in a collaborative manner with the Associate Dean of Clinical Affairs and Community Outreach, the Chair of the Department of Pharmacy Practice and experiential coordinators / staff of the College to execute the COP vision for an exceptional and innovative experiential education curriculum, both Introductory Pharmacy Practice Experiences and Advanced Pharmacy Practice Experiences. The Director will be responsible for preceptor and site recruitment, training, development, assessment, and recognition.

# **ESSENTIAL DUTIES AND RESPONSIBILITIES**

- Assists with assigning student clinical placements through site solicitation, placement selection and communication with students and preceptors.
- Provides general operational and administrative support for all aspects of the experiential program including but not limited to introductory and advanced practice experiences.
- Communicates and problem solves regularly with clinical sites regarding scheduled clinical placements/changes, requested student and preceptor evaluations, and other general questions.
- Communicates and forwards necessary material to developing new sites including appropriate clinical affiliation agreement templates, rotation requirements, rotation goals and objectives, clinical manual and verification of current liability insurance, provider license(s) and board certifications.
- Attends local and state pharmacy professional meetings, such as OCPhA and OCSHP and other professional conferences for preceptor recruitment.
- Primary responsibilities includes new and ongoing hospital relationships.
- Collects quality assurance and improvement data of the IPPE/APPE Experiential Program.
- Provides mentorship to preceptors and pharmacists at practice sites.
- Assists in evaluating the performance of existing preceptors and practice sites as well as assessing potential preceptors and practice sites for participation in the experiential education program.
- Conducts site visits and evaluate preceptor and student experiences to ensure quality
- Recruitment and development of IPPE/APPE experiential sites.
- Recruit and train preceptors.
- Develop and implement initiatives to recognize excellence in precepting students.
- Communicates and assists international and out of state site contacts with logistics of student placements including all required documentation.
- Assists Associate Dean of Clinical Affairs and Community Outreach with training of students and preceptors in with IPPE and APPE rotation requirements. Uses Microsoft Office, E-Value ® and MyRecordTracker applications for correspondence, forms,

- reports, minutes, committee lists and other related documents.
- Serves as an information resource for students, applicants, faculty, staff and to the public on issues related to the program.

#### **QUALIFICATION REQUIREMENTS**

- Language Skills: Excellent written and verbal communication skills. Ability to read, analyze and
  interpret University policies and legal documents. Ability to appropriately respond to common

  education.

- Reasoning Abilities: Ability to define problems, collect data, establish facts and draw valid
  conclusions to solve problems and plan initiatives. Demonstrated ability to interpret an
  extensive variety of technical instructions and deal with various abstract and concrete
  variables.
